### 2. TERMS OF APPOINTMENT AND RESPONSIBILITIES




#### 10. EMPLOYEE SURVEILLANCE

#### 12. INDEMNITY



# EXPLANATION OF COMPENSATION STRUCTURE AND EMPLOYEE BENEFITS
